THE FUNERAL FUND

The South Australian Pensioners' Association was formed in 1932 and is the oldest association of its kind in South Australia.

The aims of our Association are to provide a social environment in which pensioners or retirees can regularly meet and enjoy activities in the company of people their own age and situation and to provide a safe, secure Funeral Fund .

The Fund was established in 1933 and was created for the purpose of providing our members with the ability to save for all or part of their Funeral so that it will be carried for them in the manner in which they would desire and so that they will not be a burden on their next of kin.

ABOUT US

- Our Funeral Fund is designed for the benefit and convenience of low-income earners.
- It is a savings plan for your funeral, not a pre-paid funeral or funeral fund bond.
- There are no fixed payment commitments. You only pay into the Fund whenever you wish and pay whatever you wish, up to a current maximum of \$13,500. Members may join the fund by making an initial minimum contribution of \$100. This is not a fee and is credited to your account immediately.
- Thereafter, voluntary contributions (of not less than \$10) may then be made at any time at the member's convenience.
- The funds are invested in secure financial areas only, as recommended by licensed professional fund managers who have been approved by the Department of Treasury and Finance.
- Distribution of the income earned by the Fund are allocated and statements sent out every 12 months in December.
- You choose your own Funeral Director and can change this option at any time.
- The Fund benefit will be paid out on your death to either your next of kin, your executor, or a person responsible for payment of your funeral, or to the Funeral director direct, with any surplus going to your estate.
- The Fund has in excess of \$3 million held on behalf of our members and has continued to grow each year.
- Excellent distributions have been earned as the table below indicates.
- An administration fee of 5% is deducted on payment of the death benefit. The Funeral Fund is available to members of the Association*.

**Annual Membership is \$12.50 and should be included with the initial contribution for those who are not already members of the Association.*

The only compulsory stipulation is that a person must at all times remain a financial member of the Association, in order to protect the dividends earned on their contributions.

The Constitution of the Funeral Fund ensures that members are protected at all times. For example, it is a sad fact that many people lose their ability to control their affairs as they age, or move to Retirement villages, or Aged Care complexes, or away from the area and forget to maintain their membership in the Association. To prevent a member from being deprived of their rightful dividends, their annual membership fee, if it falls into arrears, is deducted from the accrued benefits and so the member is therefore protected at all times.
